The incentive offer

Achievement level	Whole-building energy savings	Incentive level
Tier 1	15% savings	25% of cost
Tier 2	20% savings	35% of cost
Tier 3	25% savings	40% of cost

For qualified low-income multi-family housing, incentives are doubled.

When your property tier level is established, an improvement plan will identify what actions are needed to achieve the savings and reap the incentive reward.

The whole-building approach is unique. Whether your building is master metered or utilities are paid through your residents, all energy savings through this program are all counted toward your achievement goal. Now you'll be looking for efficiencies everywhere, which may include appliances or equipment inside resident units as energy-saving measures.
